The Cyprus Securities and Exchange Commission («CySEC») wishes to inform the persons registered in the public register («certified persons») of the following:

- 3. The participation fee is €120 per participant, per seminar.



- 4. The seminars are addressed primarily to the persons registered in the public register («certified persons») for purposes of compliance with paragraph 17(2) of the Directive regarding the certification of persons and the public register (R.A.D. 174/2015 as amended).

Registrations will be made only through the <u>online application form</u> that can be found in this <u>link</u>.

Payments will be performed only through the JCC portal, as directed by the automated system.

A registration will be considered as completed only when the payment is made. When the registration is completed, a confirmation will be automatically sent to the email provided.

6. Due to the restricted number of places (up to thirty (30) participants per seminar), the applications for participation in the seminars will be served on a first-come, first-served basis.

Late registration fee:

The registration forms must be submitted **no later than the Wednesday**, the week before each seminar. For registrations after Wednesday, a late registration fee of 30% (€36) will be charged.

Early Registration Discount:

For registrations before 14:00 the Friday a week before the seminar (8 days ahead), an Early Registration Discount of €20 will be applied.

Registration Instructions

For registering to Cyprus Securities and Exchange Commission's seminars, the following procedure must be performed:

- 1. Access to the list of the available seminars through this link.
 - a. The seminars are listed according to the day of Delivery (the ones that will be delivered first are higher in the list).
 - b. Date and location of the seminar appears below the seminar title.
 - c. The available seats for each seminar is indicated.
- **2.** By clicking on the seminar title, further details are displayed (including the analytical program in the form of downloadable pdf) and the registration process can be initiated.
 - a. The Name as it will appear on the certificate must be completed (mandatory)
 - b. The Certification Number can be added (not mandatory).
 - c. Click "ADD TO CART" to move to the next window.
- **3.** If you would for another seminar or another person is to be added, click on "continue shopping" and repeat steps 1 and 2". If no other addition is to be made, click on "CHECK OUT".
- 4. Complete personal and Company details in steps 2 and 3 and click "NEXT"
- **5.** At step 4, from the dropdown menu, choose "JCC" and click "NEXT".
- **6.** At step 5, once the accuracy of the order is confirmed, click "ORDER NOW".
- **7.** Step 6 is the payment. The required details must be completed.
